Crates may be set up between 5-6 pm on Friday

Dogs jumping 24", dogs entered for exhibition only and dogs that have a permanent registration height card DO NOT need to be measured. **Please be sure to check the height measurement sheet online to be sure you are not on it.**

You should have received a previous email that contained the information regarding your entry. It is YOUR responsibility to check the information carefully and notify the Trial Secretary of any errors or omissions as soon as possible.

Due to the placement of the restrooms, on the other side of the arena, you will need to go outside and through another door to access them; signs will be posted; unfortunately dogs are not allowed in this area. (Landlords)

There will be NO crating in the arena.

** We are asking that dogs not running within 10 dogs, not be in the spectator/arena area as space is limited and we want room for dogs to enter and exit the arena safely.**

We will have designated areas for warm up and waiting to go into the ring.
Please DO NOT BLOCK these areas.

Please pick up after your dog. There will be trash cans outside for this.

All Dogs must be on leash or crated unless in the ring or in the warm up area. Offenders will be asked to leave without a refund.

DIRECTIONS TO TRIAL SITE

From the South

From routes 95/ 495 take Route 3 (Everett Turnpike in NH). – Take NH Exit 6 turn right at end of ramp (Broad Street). Take a right at the end of Broad Street onto Amherst St. Bear right at second set of lights (not counting blinker) onto Main Street. Turn left at next set of lights onto Canal St (Dunkin Donuts on corner). Pass Nashua Farmers' Exchange. Turn left at Riverside Business Park, 48 Bridge St. Follow driveway to left. Pass green building with tan stripe and red building to tan building with ramp.

From the North

From Manchester and north take Everett Turnpike Exit 6. Turn left at end of ramp (Broad St). Take a right at the end of Broad Street onto Amherst Street. Bear right at second set of lights (not counting blinker) onto Main St. Turn left at next set of lights onto Canal St (Dunkin Donuts on corner). Pass Nashua Farmers' Exchange. Turn left at Riverside Business Park, 48 Bridge St. Follow left driveway. Pass green building with tan stripe and red building to tan building with ramp
